SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

SB20-159 be amended as follows:

- 1 Amend printed bill, page 4, line 5, strike "**facility-specific**".
- 2 Page 4, line 20, after "THE" insert "OFFICE OF THE STATE ARCHITECT
- 3 WITHIN THE".
- 4 Page 4, strike lines 21 and 22 and substitute "BY POLICY A".
- 5 Page 4, line 26, strike "SET" and substitute "BASE".
- 6 Page 4, line 27, strike "AT" and substitute "ON".
- 7 Page 5, line 1, strike "FACILITY-SPECIFIC".
- 8 Page 5, line 2, after "THE" insert "OFFICE OF THE STATE ARCHITECT
- 9 WITHIN THE".
- 10 Page 5, line 4, strike "DECLARATIONS." and substitute "DECLARATIONS
- 11 AND SHALL INCLUDE TRANSPORTATION-RELATED EMISSIONS AS PART OF
- 12 THE GLOBAL WARMING POTENTIAL EMISSIONS.".
- 13 Page 5, line 7, strike "FACILITY-SPECIFIC".
- 14 Page 5, line 23, strike "DOWNWARD".
- 15 Page 5, strike lines 24 and 25 and substitute "REFLECT INDUSTRY
- 16 CONDITIONS. THE DEPARTMENT SHALL".
- 17 Page 5, line 27, after "(a)" insert "(I)" and after "CONTRACTS FOR" insert
- 18 "THE DESIGN OF".
- 19 Page 6, line 1, strike "2021," and substitute "2022,".
- 20 Page 6, line 2, strike "CONTRACTOR" and substitute "DESIGNER".
- 21 Page 6, line 3, strike "FACILITY-SPECIFIC".
- 22 Page 6, strike lines 7 though 16 and substitute "UNIFORM STANDARDS IN
- 23 DATA COLLECTION, AS SET BY POLICY BY THE OFFICE OF THE STATE
- 24 ARCHITECT WITHIN THE DEPARTMENT FOR EACH ELIGIBLE MATERIAL
- 25 PROPOSED TO BE USED IN THE PUBLIC PROJECT THAT MEET THE MAXIMUM
- 26 ACCEPTABLE GLOBAL WARMING POTENTIAL FOR EACH CATEGORY OF

1 ELIGIBLE MATERIALS OR, IN THE ALTERNATIVE, A MAXIMUM ACCEPTABLE  
2 GLOBAL WARMING POTENTIAL FOR THE PROJECT IN THE AGGREGATE.

3 (II) IF A PRODUCT THAT MEETS THE MAXIMUM GLOBAL WARMING  
4 POTENTIAL FOR A CATEGORY OF ELIGIBLE MATERIALS IS NOT PRICED OR IS  
5 NOT AVAILABLE ON A REASONABLE BASIS AT THE TIME OF DESIGN OR  
6 CONSTRUCTION, THE OFFICE OF THE STATE ARCHITECT WITHIN THE  
7 DEPARTMENT MAY WAIVE THE REQUIREMENTS OF THIS SECTION FOR THAT  
8 PRODUCT.

9 (b) FOR INVITATION FOR BIDS FOR CONTRACTS FOR PUBLIC  
10 PROJECTS ISSUED ON OR AFTER JULY 1, 2022, AN AGENCY OF GOVERNMENT  
11 SHALL SPECIFY THE ELIGIBLE MATERIALS THAT WILL BE USED IN THE  
12 PROJECT.".

13 Page 6, line 18, strike "FACILITY-SPECIFIC".

14 Page 6, line 24, strike "A FACILITY-SPECIFIC" and substitute "AN".

15 Page 6, line 26, after "SECTION." add "THE ENVIRONMENTAL PRODUCT  
16 DECLARATION SHALL BE DEEMED APPROVED IF IT COMPLIES WITH THE  
17 ORIGINAL SPECIFICATION. IF AN ENVIRONMENTAL PRODUCT DECLARATION  
18 IS NOT AVAILABLE FOR AN ELIGIBLE MATERIAL, THE CONTRACTOR SHALL  
19 NOTIFY THE AGENCY OF GOVERNMENT AND INSTALL THE ELIGIBLE  
20 MATERIAL AS ORIGINALLY SPECIFIED. IF A PRODUCT MEETING THE  
21 MAXIMUM GLOBAL WARMING POTENTIAL FOR A CATEGORY OF ELIGIBLE  
22 MATERIALS IS NOT PRICED OR IS NOT AVAILABLE TO THE CONTRACTOR ON  
23 A REASONABLE BASIS, THE AGENCY OF GOVERNMENT MAY WAIVE THE  
24 REQUIREMENTS OF THIS SECTION FOR THAT PRODUCT. THE AGENCY OF  
25 GOVERNMENT SHALL REPORT WAIVERS TO THE OFFICE OF THE STATE  
26 ARCHITECT WITHIN THE DEPARTMENT.".

27 Page 7, line 2, after "TIME." add "REDUCTION OF GREENHOUSE GAS  
28 EMISSIONS ACHIEVED UNDER THIS SECTION SHALL BE CREDITED UNDER  
29 THE PROCESS CREATED IN SECTION 25-7-105 (1)(e).".
