

SENATE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 10, line 13, after the period insert "THE
2 EXECUTIVE DIRECTOR SHALL APPOINT THE MEMBERS OF THE RULES
3 ADVISORY COUNCIL, TAKING INTO CONSIDERATION A LIST OF NOMINEES
4 PROVIDED BY THE EARLY CHILDHOOD LEADERSHIP COMMISSION PURSUANT
5 TO THIS SUBSECTION (2)(a).".

6 Page 10, line 16, strike "EXECUTIVE DIRECTOR" and substitute "EARLY
7 CHILDHOOD LEADERSHIP COMMISSION".

8 Page 10, strike line 19 and substitute "APPLICATIONS FROM QUALIFIED
9 AND INTERESTED INDIVIDUALS TO SERVE ON THE COUNCIL. IN ADDITION TO
10 SOLICITING APPLICATIONS, THE EARLY CHILDHOOD LEADERSHIP
11 COMMISSION SHALL CONSULT WITH PARENTS AND WITH COUNTIES,
12 COUNTY HUMAN SERVICES DIRECTORS, SCHOOL DISTRICTS, PROVIDERS,
13 AND THE ORGANIZATIONS THAT REPRESENT THESE ENTITIES AND SHALL
14 ACCEPT NOMINATIONS FROM SAID ORGANIZATIONS. BASED ON THE
15 APPLICATIONS AND NOMINATIONS RECEIVED, THE EARLY CHILDHOOD
16 LEADERSHIP COMMISSION SHALL SUBMIT TO THE EXECUTIVE DIRECTOR A
17 LIST OF NOMINEES FOR CONSIDERATION AS APPOINTMENTS TO THE
18 COUNCIL. TO THE EXTENT PRACTICABLE, THE LIST OF NOMINEES MUST
19 INCLUDE NOMINEES THAT SATISFY THE REQUIREMENTS SPECIFIED IN
20 SUBSECTIONS (2)(b), (2)(c), AND (2)(d) OF THIS SECTION. THE EARLY
21 CHILDHOOD LEADERSHIP COMMISSION SHALL SUBMIT A LIST OF NOMINEES
22 TO THE EXECUTIVE DIRECTOR AS PROVIDED IN THIS SUBSECTION (2)(a) FOR
23 THE INITIAL AND SUBSEQUENT APPOINTMENTS TO THE COUNCIL.

24 (b) The".

25 Reletter succeeding paragraphs accordingly.

26 Page 10, line 20, strike "PERSONS" and substitute "PERSONS, TAKING INTO
27 CONSIDERATION THE LIST OF NOMINEES RECEIVED FROM THE EARLY
28 CHILDHOOD LEADERSHIP COMMISSION,".

29 Page 10, line 21, after "WHICH" insert "APPOINTMENTS".

30 Page 11, line 1, after "PROGRAM" insert "OR IN-HOME CHILD CARE".

31 Page 11, strike lines 4 and 5 and substitute:

32 "(II) REPRESENTATIVES OF COUNTY DEPARTMENTS, AS DEFINED IN
33 SECTION 26.5-4-103, IN DIVERSE GEOGRAPHIC AREAS OF THE STATE WHO

1 ARE KNOWLEDGEABLE OF AND RESPONSIBLE FOR IMPLEMENTING CHILD
2 PROTECTION PROGRAMS AND THE COLORADO CHILD CARE ASSISTANCE
3 PROGRAM AND HAVE EXPERTISE IN FISCAL MATTERS FOR COUNTY
4 DEPARTMENTS. NOTWITHSTANDING ANY PROVISION OF THIS SUBSECTION
5 (2)(b) TO THE CONTRARY, THE EXECUTIVE DIRECTOR SHALL APPOINT AT
6 LEAST TWO PERSONS FROM THE CATEGORY DESCRIBED IN THIS SUBSECTION
7 (2)(b)(II).".

8 Page 12, line 20, strike "(2)(f)(II)" and substitute "(2)(g)(II)".
