1 Amend printed bill, page 209, line 1, after "SERVICES." insert "In
2 ESTABLISHING THE PER-CHILD RATES, THE DEPARTMENT, AT A MINIMUM,
3 SHALL ENSURE THAT THE PER-CHILD RATE FOR PRESCHOOL SERVICES FOR
4 CHILDREN WITH DISABILITIES IS AT LEAST EQUAL TO THE GREATER OF THE
5 PER-CHILD RATE FOR UNIVERSAL PRESCHOOL SERVICES OR THE STATE PER
6 PUPIL PRESCHOOL FUNDING RATE FOR THE 2022-23 BUDGET YEAR, AS
7 DEFINED IN SUBSECTION (6) OF THIS SECTION."

8 Page 219, after line 7 insert:

9 "(6) FOR PURPOSES OF THIS SECTION, UNLESS THE CONTEXT
10 OTHERWISE REQUIRES:

11 (a) "DISTRICT EXTENDED HIGH SCHOOL PUPIL ENROLLMENT" HAS
12 THE SAME MEANING AS PROVIDED IN SECTION 22-54-103.

13 (b) "FUNDED PUPIL COUNT" HAS THE SAME MEANING AS PROVIDED
14 IN SECTION 22-54-103.

15 (c) "ONLINE PUPIL ENROLLMENT" HAS THE SAME MEANING AS
16 PROVIDED IN SECTION 22-54-103.

17 (d) "STATE AVERAGE PER PUPIL FUNDING AMOUNT" MEANS THE
18 STATEWIDE TOTAL AMOUNT OF PER PUPIL FUNDING, AS DESCRIBED IN
19 SECTION 22-54-104(3) OR (3.5), CALCULATED FOR ALL SCHOOL DISTRICTS
20 FOR THE 2022-23 BUDGET YEAR DIVIDED BY THE STATEWIDE TOTAL
21 FUNDED PUPIL COUNT, MINUS THE STATEWIDE TOTAL DISTRICT EXTENDED
22 HIGH SCHOOL PUPIL ENROLLMENT AND THE STATEWIDE TOTAL ONLINE
23 PUPIL ENROLLMENT, FOR THE 2022-23 BUDGET YEAR.

24 (e) "STATE PER PUPIL PRESCHOOL FUNDING RATE FOR THE 2022-23
25 BUDGET YEAR" MEANS AN AMOUNT EQUAL TO THE STATE'S SHARE
26 PERCENTAGE OF STATEWIDE TOTAL PROGRAM FUNDING FOR ALL SCHOOL
27 DISTRICTS CALCULATED PURSUANT TO THE "PUBLIC SCHOOL FINANCE ACT
28 OF 1994", ARTICLE 54 OF TITLE 22, FOR THE 2022-23 BUDGET YEAR
29 MULTIPLIED BY THE STATE AVERAGE PER PUPIL FUNDING AMOUNT FOR THE
30 2022-23 BUDGET YEAR."
