1 Amend printed bill, page 344, after line 23 insert:

2 "SECTION 10. In Colorado Revised Statutes, 22-54-108, **amend**
3 (3)(b)(I) and (3)(b)(IV)(C); and **add** (3)(b)(V) as follows:

4 **22-54-108. Authorization of additional local revenues -**
5 **definition.** (3) (b) (I) Except as otherwise provided in ~~subparagraphs (H),~~
6 ~~(HH), and (IV) of this paragraph (b)~~ SUBSECTIONS (3)(b)(II), (3)(b)(III),
7 (3)(b)(IV), AND (3)(b)(V) OF THIS SECTION, the total additional local
8 property tax revenues that may be received pursuant to elections held
9 pursuant to this section ~~shall~~ MUST not exceed under any circumstances
10 twenty percent of the district's total program, as determined pursuant to
11 section 22-54-104 (2), or two hundred thousand dollars, whichever is
12 greater.

13 (IV) (C) For purposes of this ~~subparagraph (IV)~~ SUBSECTION
14 (3)(b)(IV) AND SUBSECTION (3)(b)(V) OF THIS SECTION, a "small rural
15 district" is a district in Colorado that the department of education
16 determines is rural, based on the geographic size of the district and the
17 distance of the district from the nearest large, urbanized area, and that
18 enrolls fewer than one thousand students in kindergarten through twelfth
19 grade.

20 (V) (A) ON AND AFTER JULY 1, 2023, AND SUBJECT TO THE
21 PROVISIONS OF SUBSECTION (3)(b)(V)(B) OF THIS SECTION, THE TOTAL
22 ADDITIONAL LOCAL PROPERTY TAX REVENUES THAT A SMALL RURAL
23 DISTRICT MAY RECEIVE PURSUANT TO AN ELECTION HELD PURSUANT TO
24 THIS SECTION MUST NOT EXCEED UNDER ANY CIRCUMSTANCES: THIRTY
25 PERCENT OF THE DISTRICT'S TOTAL PROGRAM PLUS THE AMOUNT OF
26 FUNDING THE DISTRICT RECEIVES FOR CHILDREN ENROLLED IN THE
27 COLORADO UNIVERSAL PRESCHOOL PROGRAM PURSUANT TO PART 2 OF
28 ARTICLE 4 OF TITLE 26.5 OR TWO HUNDRED THOUSAND DOLLARS,
29 WHICHEVER IS GREATER; PLUS AN AMOUNT EQUAL TO THE MAXIMUM
30 DOLLAR AMOUNT OF PROPERTY TAX REVENUE THAT THE SMALL RURAL
31 DISTRICT COULD HAVE GENERATED FOR THE 2001-02 BUDGET YEAR IF, IN
32 ACCORDANCE WITH THE PROVISIONS OF SECTION 22-54-107.5, THE SMALL
33 RURAL DISTRICT SUBMITTED A QUESTION TO AND RECEIVED APPROVAL OF
34 THE ELIGIBLE ELECTORS OF THE DISTRICT AT AN ELECTION HELD IN
35 NOVEMBER 2001.

36 (B) REGARDLESS OF THE APPLICABILITY OF SECTION 22-54-104
37 (5)(g), FOR PURPOSES OF THIS SUBSECTION (3)(b)(V), A SMALL RURAL
38 DISTRICT'S TOTAL PROGRAM IS THE AMOUNT CALCULATED PURSUANT TO
39 SECTION 22-54-104 (2).".
