

HB25-1192 be amended as follows:

1 Amend printed bill, page 4, strike lines 24 through 27.

2 Strike pages 5 and 6.

3 Page 7, strike lines 1 through 7 and substitute:

4 "SECTION 3. In Colorado Revised Statutes, 22-2-136, **amend**
5 (2)(b) and (2)(c); and **add** (2)(d) as follows:

6 **22-2-136. Additional duty - state board - individual career and**
7 **academic plans - standards - rules.** (2) In establishing the standards for
8 individual career and academic plans, the state board shall ensure, at a
9 minimum, that:

10 (b) Each individual career and academic plan is accessible to
11 educators, students, and parents; ~~and~~

12 (c) Each public school, in assisting students and parents in
13 creating and maintaining the individual career and academic plans, is in
14 compliance with the requirements of the federal "Family Educational
15 Rights and Privacy Act of 1974", 20 U.S.C. sec. 1232g; AND

16 (d) (I) BEGINNING WITH THE 2027-28 SCHOOL YEAR, EACH
17 INDIVIDUAL CAREER AND ACADEMIC PLAN INCLUDES A REQUIREMENT
18 THAT, DURING THE STUDENT'S GRADUATION YEAR, THE STUDENT
19 COMPLETES A FREE APPLICATION FOR FEDERAL STUDENT AID OR THE
20 COLORADO APPLICATION FOR STATE FINANCIAL AID.

21 (II) NOTWITHSTANDING SUBSECTION (2)(d)(I), A STUDENT IS NOT
22 REQUIRED TO COMPLETE A FREE APPLICATION FOR FEDERAL STUDENT AID
23 OR THE COLORADO APPLICATION FOR STATE FINANCIAL AID IF:

24 (A) THE STUDENT AFFIRMATIVELY DECLINES TO COMPLETE THE
25 APPLICATION; OR

26 (B) AUTHORIZED SCHOOL PERSONNEL DETERMINES IT IS NOT
27 FEASIBLE FOR THE STUDENT TO COMPLETE AN APPLICATION.

28 (III) IF A STUDENT HAS NOT COMPLETED THE APPLICATION OR
29 AFFIRMATIVELY DECLINED TO COMPLETE THE APPLICATION PURSUANT TO
30 SUBSECTION (2)(d)(II)(A) OF THIS SECTION BY MAY 1 OF THE APPLICABLE
31 SCHOOL YEAR, THE PUBLIC SCHOOL MUST INDICATE ON THE STUDENT'S
32 INDIVIDUAL CAREER AND ACADEMIC PLAN THAT THE STUDENT HAS
33 DECLINED TO COMPLETE AN APPLICATION."
