17 TRANSACTION AT ISSUE AND THAT PREEMPTS STATE LAW.

21 A UTILITY PROVIDER FOR SERVICE TO A TENANT'S DWELLING UNIT."."

24 substitute "THE AMOUNT CHARGED FOR THAT".
- 25 Page 8 of the bill, line 14, strike "PROPERTY;" and substitute "PROPERTY
26 THAT IS NOT PART OF THE TOTAL PRICE;".
- 27 Page 8 of the bill, line 15, strike A" and substitute "THAT".
- 28 Page 8 of the bill, line 16, strike "CHARGED;" and substitute "CHARGED
