

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public & Behavioral Health & Human Services.

HB22-1281 be amended as follows:

- 1   Amend printed bill, page 8, line13, strike "**contributing**" and substitute "**matching**".
- 3   Page 8, line 16, after "TOOL" insert "OR A COUNTY, REGIONAL, OR  
4   COMMUNITY ASSESSMENT TOOL".
- 5   Page 9, lines 1 and 2, strike "CONTRIBUTING FUNDS OR NONFINANCIAL  
6   CONTRIBUTING" and substitute "MATCHING".
- 7   Page 9, line 2, strike "(3)" and substitute "(3)(a)".
- 8   Page 9, line 4, strike "CONTRIBUTING FUNDS" and substitute "MATCHING  
9   RESOURCES".
- 10   Page 9, strike lines 21 through 24 and substitute: "THAT OFFER A  
11   MONETARY MATCH IN RESOURCES, WHICH MAY INCLUDE COMMUNITY  
12   BENEFIT FUNDS, OR IN-KIND CONTRIBUTIONS, WHICH MAY INCLUDE LOCAL  
13   COLLABORATION, THAT DIRECTLY SUPPORT THE BEHAVIORAL HEATH-CARE  
14   SERVICES PROVIDED WITH A GRANT AWARD. THE BHA MAY WAIVE THE  
15   MATCHING RESOURCES REQUIREMENT FOR AN".
- 16   Page 9, lines 26 and 27, strike "CONTRIBUTING FUNDS" and substitute  
17   "MATCHING RESOURCES".
- 18   Page 10, strike lines 3 through 6 and substitute:
  - 19     "(b) IN DETERMINING WHETHER AN APPLICANT HAS IDENTIFIED A  
20     GAP IN SERVICES ON THE BEHAVIORAL HEALTH-CARE SERVICE CONTINUUM,  
21     THE BHA SHALL ACCEPT THE RESULTS OF AN ASSESSMENT CONDUCTED BY  
22     THE APPLICANT WITH THE BEHAVIORAL HEALTH-CARE SERVICES  
23     ASSESSMENT TOOL DEVELOPED BY THE BHA OR A COUNTY, REGIONAL, OR  
24     COMMUNITY ASSESSMENT TOOL THAT DEMONSTRATES GAPS IN SERVICES.
  - 25     "(c) A PROGRAM FUNDED BY A GRANT AWARD MUST COMPLY WITH  
26     THE FEDERAL "AMERICANS WITH DISABILITIES ACT OF 1990", 42 U.S.C.  
27     SEC.12101 ET SEQ., AS AMENDED, AND SERVE INDIVIDUALS WITH A  
28     DISABILITY, AS DEFINED IN THE FEDERAL ACT, REGARDLESS OF PRIMARY  
29     DIAGNOSIS, CO-OCCURRING CONDITIONS, OR IF THE INDIVIDUAL REQUIRES  
30     ASSISTANCE WITH ACTIVITIES OF DAILY LIVING, AS DEFINED IN SECTION  
31     12-270-104.".
- 32   Page 10, lines 19 and 20, strike "CONTRIBUTING FUNDS OR NONFINANCIAL  
33   CONTRIBUTING" and substitute "MATCHING".
