

## HOUSE FLOOR AMENDMENT

Third Reading

1 Amend revised bill, page 17, strike lines 10 through 15 and substitute:

2       **"24-32-3310. Local enforcement.** (1) Nothing in this part 33 may  
3 interfere with the right of local governments to enforce local rules  
4 governing the installation of factory-built housing pursuant to section  
5 24-32-3318 that bear the insignia of approval issued by the division  
6 pursuant to section 24-32-3311 (1)(a) if the local rules are not  
7 inconsistent with state rules adopted pursuant to section 24-32-3305."

8 Page 17, lines 16 and 17, strike "THE REPEAL OF SUBSECTION (1) OF THIS  
9 SECTION WILL TAKE EFFECT" and substitute "THIS SECTION IS REPEALED,  
10 EFFECTIVE".

11 Page 17, lines 23 and 24, strike "THE REPEAL OF SUBSECTION (1) OF THIS  
12 SECTION WILL TAKE EFFECT" and substitute "THIS SECTION IS REPEALED".

13 Page 19, strike lines 14 through 27 and substitute:

14       "(8) THE BOARD SHALL NOTIFY THE REVISOR OF STATUTES IN  
15 WRITING, BY EMAILING THE NOTICE TO  
16 REVISOROFSTATUTES.GA@COLEG.GOV, OF THE DATE ON WHICH THE  
17 BOARD ADOPTS RULES ESTABLISHING REQUIREMENTS BASED ON THE  
18 RECOMMENDATIONS OF THE ADVISORY COMMITTEE PURSUANT TO SECTION  
19 24-32-3305 (3)(c) TO (3)(e).".

20 Page 20, strike line 2 and substitute "(1) and (2)(a) as follows:".

21 Page 20, strike lines 4 though 8 and substitute:

23       "(1) (a) Except as authorized in section 24-32-3329, a local  
24 government shall not adopt less stringent standards for an installation than  
25 those promulgated by the division. A local government shall not, without  
26 express consent by the division, adopt different standards than the  
27 standards for an installation promulgated by the division.

28       (b) THIS SUBSECTION (1) IS REPEALED ONLY IF THE BOARD ADOPTS  
29 RULES ESTABLISHING REQUIREMENTS BASED ON THE RECOMMENDATIONS  
30 OF THE ADVISORY COMMITTEE PURSUANT TO SECTION 24-32-3305 (3)(c)  
31 TO (3)(e). THE BOARD SHALL NOTIFY THE REVISOR OF STATUTES IN  
32 WRITING OF THE DATE ON WHICH THE CONDITION SPECIFIED IN THIS  
33 SUBSECTION HAS OCCURRED BY EMAILING THE NOTICE TO  
34 REVISOROFSTATUTES.GA@COLEG.GOV. THIS SUBSECTION (1) IS REPEALED

1 UPON THE DATE IDENTIFIED IN THE NOTICE THAT THE BOARD HAS ADOPTED  
2 RULES ESTABLISHING REQUIREMENTS BASED ON THE RECOMMENDATIONS  
3 OF THE ADVISORY COMMITTEE PURSUANT TO SECTION 24-32-3305 (3)(c)  
4 TO (3)(e), OR, IF THE NOTICE DOES NOT SPECIFY THAT DATE, UPON THE  
5 DATE OF THE NOTICE TO THE REVISOR OF STATUTES."

7 Page 20, strike lines 14 through 27.

8 Page 21, strike line 1.

9 Page 22 before line 26 insert:

10 "SECTION 18. Effective Date. (1) Except as otherwise provided  
11 in this section, this act takes effect upon passage.

12 (2) Section 24-32-3311 (4), amended in section 12 of this act, and  
13 section 24-32-3311 (7), enacted in section 12 of this act, take effect only  
14 if the revisor of statutes receives notice pursuant to 24-32-3311 (8),  
15 enacted in section 12 of this act. Section 24-32-3311 (4) and (7) take  
16 effect upon the date identified in such notice, or, if the notice does not  
17 specify that date, upon the date of the notice to the revisor of statutes."

19 Renumber succeeding section accordingly.
