

## HOUSE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 17, line 3, strike "**repeal**" and substitute  
2 "**amend**".

3 Page 17, line 5, after "**enforcement**". insert "(1)".

4 Page 17, after line 10 insert:

5       "(2) THE REPEAL OF SUBSECTION (1) OF THIS SECTION WILL TAKE  
6 EFFECT ONLY IF THE BOARD ADOPTS RULES ESTABLISHING REQUIREMENTS  
7 BASED ON THE RECOMMENDATIONS OF THE ADVISORY COMMITTEE  
8 PURSUANT TO SECTION 24-32-3305 (3)(c) TO (3)(e), COLORADO REVISED  
9 STATUTES. THE BOARD SHALL NOTIFY THE REVISOR OF STATUTES IN  
10 WRITING OF THE DATE ON WHICH THE CONDITION SPECIFIED IN THIS  
11 SECTION HAS OCCURRED BY EMAILING THE NOTICE TO  
12 REVISOROFSTATUTES.GA@COLEG.GOV. THE REPEAL OF SUBSECTION (1) OF  
13 THIS SECTION WILL TAKE EFFECT UPON THE DATE IDENTIFIED IN THE  
14 NOTICE THAT THE BOARD HAS ADOPTED RULES ESTABLISHING  
15 REQUIREMENTS BASED ON THE RECOMMENDATIONS OF THE ADVISORY  
16 COMMITTEE PURSUANT TO SECTION 24-32-3305 (3)(c) TO (3)(e),  
17 COLORADO REVISED STATUTES, OR, IF THE NOTICE DOES NOT SPECIFY  
18 THAT DATE, UPON THE DATE OF THE NOTICE TO THE REVISOR OF  
19 STATUTES.".

20 Page 17, line 12, after "(7)" insert "and (8)".

21 Page 18, after line 12 insert:

22       (8) SUBSECTIONS (4), AS AMENDED, AND (7) OF THIS SECTION WILL  
23 TAKE EFFECT ONLY IF THE BOARD ADOPTS RULES ESTABLISHING  
24 REQUIREMENTS BASED ON THE RECOMMENDATIONS OF THE ADVISORY  
25 COMMITTEE PURSUANT TO SECTION 24-32-3305 (3)(c) TO (3)(e),  
26 COLORADO REVISED STATUTES. THE BOARD SHALL NOTIFY THE REVISOR  
27 OF STATUTES IN WRITING OF THE DATE ON WHICH THE CONDITION  
28 SPECIFIED IN THIS SECTION HAS OCCURRED BY EMAILING THE NOTICE TO  
29 REVISOROFSTATUTES.GA@COLEG.GOV. SUBSECTIONS (4), AS AMENDED,  
30 AND (7) OF THIS SECTION WILL TAKE EFFECT UPON THE DATE IDENTIFIED  
31 IN THE NOTICE THAT THE BOARD HAS ADOPTED RULES ESTABLISHING  
32 REQUIREMENTS BASED ON THE RECOMMENDATIONS OF THE ADVISORY  
33 COMMITTEE PURSUANT TO SECTION 24-32-3305 (3)(c) TO (3)(e),  
34 COLORADO REVISED STATUTES, OR, IF THE NOTICE DOES NOT SPECIFY  
35 THAT DATE, UPON THE DATE OF THE NOTICE TO THE REVISOR OF  
36 STATUTES.".
