 - 9 PROVIDES EXPERTISE ON THE PREVENTION OF CHILD ABUSE AND NEGLECT;

 - 11 (q) A MEMBER OF LAW ENFORCEMENT THAT WORKS DIRECTLY
 - 12 WITH VICTIMS OF CHILD ABUSE OR NEGLECT AND DOMESTIC VIOLENCE.
 - 13 (4) THE CHIEF JUSTICE OF THE COLORADO SUPREME COURT SHALL
 - 14 APPOINT THE FOLLOWING MEMBERS TO SERVE ON THE TASK FORCE:
 - 15 (a) A STATE COURT JUDGE;
 - 16 (b) AN INDIVIDUAL OTHER THAN A JUDGE WHO IS COURT
 - 17 PERSONNEL;
 - 18 (c) A DISTRICT COURT JUDGE WITH EXPERIENCE IN DOMESTIC
 - 19 MATTERS;
 - 20 (d) A COUNTY COURT JUDGE; AND
 - 21 (e) A JUDGE FROM A RURAL COUNTY."

- 23 Page 4, line 15, strike "PROGRAMS." and substitute "PROGRAMS AND THE
- 24 CHIEF JUSTICE OF THE COLORADO SUPREME COURT."
- 25 Page 4, line 16, after "PROGRAMS" add "AND CHIEF JUSTICE OF THE
- 26 COLORADO SUPREME COURT".
- 27 Page 4, line 19, after "PROGRAMS" add "AND CHIEF JUSTICE OF THE
- 28 COLORADO SUPREME COURT".
- 29 Page 4, line 21, strike "(9)" and substitute "(10)".

- 31 Page 5, line 23, strike "AND".
- 32 Page 5, after line 23, add:
 - 33 "(g) THE SCOPE OF JUDICIAL EDUCATION OPPORTUNITIES ALREADY
 - 34 PROVIDED TO JUDGES RELATED TO DOMESTIC VIOLENCE, VICTIM'S RIGHTS,
 - 35 CASE MANAGEMENT, DOMESTIC RELATIONS DOCKETS, DEPENDENCY AND
 - 36 NEGLECT DOCKETS, JUVENILE PROCEEDINGS, AND CRIMINAL PROCEEDINGS;
 - 37 (h) THE RESOURCES NECESSARY TO PROVIDE ADDITIONAL
 - 38 EDUCATION;
 - 39 (i) THE RESOURCES NECESSARY TO PROVIDE THE TIME FOR JUDGES
 - 40 TO PARTICIPATE IN ADDITIONAL EDUCATION; AND".

- 42 Page 6, line 3, strike "(9)" and substitute "(10)".
