

HOUSE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 4, line 3, strike "(2)" and substitute "(2); and
2 **add** (1)(c) and (4)".

3 Page 4, line 13, strike "and" and substitute "**and**".

4 Page 4, line 23, strike "antagonist." and substitute "antagonist; AND".

5 Page 4, after line 23 insert:

6 "(c) AN EMPLOYEE OR AGENT OF THE SCHOOL MAY FURNISH
7 OPIATE ANTAGONISTS ON SCHOOL GROUNDS OR ON A SCHOOL BUS TO ANY
8 INDIVIDUAL, INCLUDING A STUDENT, BUT SHALL ONLY FURNISH AN OPIATE
9 ANTAGONIST TO A STUDENT IF THE STUDENT HAS RECEIVED APPROPRIATE
10 SCHOOL-SPONSORED TRAINING."

11 Page 5, after line 3 insert:

12 "(4) THE GENERAL ASSEMBLY ENCOURAGES EACH SCHOOL
13 DISTRICT BOARD OF EDUCATION, THE CHARTER SCHOOL INSTITUTE, AND
14 EACH GOVERNING BOARD OF A NONPUBLIC SCHOOL TO ADOPT AND
15 IMPLEMENT A POLICY FOR AN EMPLOYEE OR AGENT OF THE SCHOOL TO
16 FURNISH AN OPIATE ANTAGONIST ON SCHOOL GROUNDS OR ON A SCHOOL
17 BUS TO ANY INDIVIDUAL, INCLUDING A STUDENT. IN DEVELOPING THE
18 POLICY, THE GENERAL ASSEMBLY ALSO ENCOURAGES EACH SCHOOL
19 DISTRICT BOARD OF EDUCATION, THE CHARTER SCHOOL INSTITUTE, AND
20 EACH GOVERNING BOARD OF A NONPUBLIC SCHOOL TO CONSIDER PARENT
21 AND STUDENT INPUT; INCLUDE EDUCATION AND TRAINING TO PARENTS
22 AND STUDENTS REGARDING OPIATE ANTAGONISTS, OPIATE DETECTION
23 TESTS, OR NON-LABORATORY DETECTION TESTS; CONSIDER
24 RECOMMENDATIONS TO STUDENTS OF A CERTAIN AGE OR GRADE LEVEL
25 FOR WHOM THE POLICY APPLIES; AND COLLABORATE WITH GROUPS WHO
26 HAVE DEVELOPED OPIATE EDUCATION AND AWARENESS CAMPAIGNS TO
27 ENHANCE THE POLICY."

28 Page 5, line 8, strike "(a)".

29 Page 5, strike lines 17 through 27.

30 Page 6, strike lines 1 and 2.

31 Page 6, strike lines 19 and 20 and substitute "SHALL NOT PROHIBIT A

1 STUDENT OF THE SCHOOL, SCHOOL DISTRICT, OR INSTITUTE CHARTER
2 SCHOOL FROM, OR DISCIPLINE A STUDENT OF THE SCHOOL, SCHOOL
3 DISTRICT, OR INSTITUTE CHARTER SCHOOL FOR POSSESSING OR
4 ADMINISTERING AN OPIATE".

5 Page 6, line 24, strike "ALLOW" and substitute "NOT PROHIBIT".

6 Page 6, line 25, strike "TO POSSESS" and substitute "FROM POSSESSING".

7 Page 7, after line 1 insert:

8 "(3) A STUDENT IS NOT SUBJECT TO CIVIL LIABILITY OR CRIMINAL
9 PROSECUTION IF THE STUDENT ACTS AS SPECIFIED IN SECTIONS
10 13-21-108.7 OR 18-1-712.".
