

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

HB24-1012 be amended as follows:

1 Amend reengrossed bill, page 2, line 3, strike "and (2)(f)" and substitute
2 "(2)(f), (4)(c), and (4)(d)".

3 Page 3, after line 24 insert:

4 "(4) The area that comprises the district extends from Wyoming
5 to New Mexico and includes:

6 (c) All areas within Huerfano, Las Animas, and Pueblo counties
7 that are not located within the territory of a metropolitan planning
8 organization and ~~are located within a county precinct, as defined in~~
9 ~~section 1-1-104 (30), that is~~ THAT ARE located wholly or partly within five
10 miles of the public right-of-way of interstate highway 25; and

11 (d) All areas within Larimer and Weld counties that are not
12 located within the territory of a metropolitan planning organization and
13 ~~are located within a county precinct, as defined in section 1-1-104 (30),~~
14 ~~that is~~ THAT ARE north of the city of Fort Collins and is located wholly or
15 partly within five miles of the public right-of-way of interstate highway
16 25."

17 Page 7, line 11, after "(1)(a)" insert "and (3)".

18 Page 8, after line 2 insert:

19 "(3) (a) Ballot issues proposed to the registered electors as
20 required by subsections (1) and (2) of this section ~~shall~~ MUST be
21 submitted in accordance with the requirements of section 20 of article X
22 of the state constitution. The action shall not take effect unless a majority
23 of the registered electors voting on the ballot issue vote to approve the
24 ballot issue.

25 (b) NO LATER THAN SIXTY DAYS BEFORE A COORDINATED OR
26 GENERAL ELECTION, THE DISTRICT MUST CERTIFY TO THE SECRETARY OF
27 STATE THE BALLOT TITLES, CONTENT, AND ORDER OF ALL BALLOT
28 MEASURES REFERRED TO THE REGISTERED ELECTORS OF THE DISTRICT BY
29 RESOLUTION OF THE BOARD. THE CONTENT MUST BE CERTIFIED IN ENGLISH
30 AND IN ANY LANGUAGE FOR WHICH ANY COUNTY WITHIN THE DISTRICT
31 MUST PROVIDE A MINORITY LANGUAGE SAMPLE BALLOT, AS DEFINED IN
32 SECTION 1-5-903 (2). IF THE DISTRICT TIMELY CERTIFIES BALLOT CONTENT
33 TO THE SECRETARY OF STATE, THE SECRETARY OF STATE MUST CERTIFY
34 THE DISTRICT'S BALLOT CONTENT TO THE COUNTY CLERK AND RECORDERS
35 OF ALL COUNTIES WHOLLY OR PARTIALLY INCLUDED IN THE DISTRICT NO
36 LATER THAN THE FIFTY-SEVENTH DAY BEFORE THE ELECTION, IN

1 ACCORDANCE WITH SECTION 1-5-203 (1)(a).
2 (c) EXCEPT FOR THE CERTIFICATION OF THE BALLOT ORDER AND
3 CONTENT BY THE SECRETARY OF STATE REQUIRED BY SUBSECTION (3)(b)
4 OF THIS SECTION, the election ~~shall~~ MUST be conducted in substantially the
5 same manner as county elections, and the county clerk and recorder of
6 each county in which the election is conducted shall assist the district in
7 conducting the election. The district shall pay the costs incurred by each
8 county in conducting ~~such an~~ THE election ON BEHALF OF THE DISTRICT AS
9 PROVIDED FOR IN SECTION 1-7-116 (2)(b). No public money of the district
10 may be used to urge or oppose passage of a ballot issue submitted for
11 voter approval as required under this section."
