HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation, Housing & Local Government.

HB24-1030 be amended as follows:

- 1 Amend printed bill, page 11, strike lines 13 and 14 and substitute
- 2 "INCLUDE RAPID TRANSIT OPERATIONS, PUBLIC TRANSPORTATION, RAIL
- 3 FIXED GUIDEWAY OPERATIONS, OR COMMUTER PASSENGER RAIL THAT:
- 4 (a) IS IN AN URBAN OR A SUBURBAN AREA; AND
- 5 (b) IS NOT CONNECTED TO A GENERAL OR AN INTERSTATE
- 6 RAILROAD SYSTEM.
- 7 (19) "SIDING" HAS THE MEANING SET FORTH IN 49 CFR 218.93."
- 8 Renumber succeeding subsections accordingly.
- 9 Page 12, line 1, strike "A RAILROAD" and substitute "ON OR BEFORE JULY
- 10 1, 2026, AND THEREAFTER, A RAILROAD".
- 11 Page 13, after line 10 insert:
- 12 "(V) RESUME AUTHORIZED SPEED ONLY AFTER THE NEXT WORKING
- 13 WAYSIDE DETECTOR INDICATES THAT THERE ARE NO LONGER ANY
- 14 DEFECTS;"
- 15 Renumber succeeding subparagraphs accordingly.
- 16 Page 13, line 18, after "LINE" insert "OR SIDING".
- 17 Page 14, line 7, strike "MAIN LINE" and substitute "TRACK IN CONNECTION
- 18 WITH RAILROAD TRANSPORTATION".
- 19 Page 14, strike lines 11 through 13 and substitute "PURSUANT TO
- 20 SUBSECTION (1) OF THIS SECTION SHALL HAVE THE ABILITY TO ENTER A
- 21 RAILROAD'S INCIDENT SITE TO INVESTIGATE THE INCIDENT. BEFORE
- 22 ENTERING, THE DESIGNATED UNION REPRESENTATIVE".
- 23 Page 18, after line 5 insert:
- 24 **40-20-309. Severability.** IF ANY PROVISION OF THIS PART 3 OR THE
- 25 APPLICATION OF THIS PART 3 TO ANY PERSON OR CIRCUMSTANCE IS HELD
- 26 INVALID, SUCH INVALIDITY DOES NOT AFFECT OTHER PROVISIONS OR
- 27 APPLICATIONS OF THIS PART 3 THAT CAN BE GIVEN EFFECT WITHOUT THE
- 28 INVALID PROVISION OR APPLICATION, AND TO THIS END THE PROVISIONS OF
- 29 THIS PART 3 ARE DECLARED TO BE SEVERABLE."
