HB24-1063 be amended as follows:

1 Amend printed bill, page 6, line 8, after "DETERMINE" insert "THE
2 PERCENTAGE OF THE SCHOOL YEAR THE CHILD WITH DISABILITIES IS IN
3 SCHOOL AND".

4 Page 8, line 11, after "DAYS" insert "AND THE PERCENTAGE OF THE
5 SCHOOL YEAR THAT".

6 Page 9, after line 10 insert:

7 "SECTION 2. In Colorado Revised Statutes, add 22-2-310 as
8 follows:

9 **22-2-310. Data reporting - instructional hours - report.**

10 (1) (a) BY THE 2025-26 SCHOOL YEAR, THE DEPARTMENT SHALL
11 STANDARDIZE THE REPORTING METHOD THAT SCHOOLS OF A SCHOOL
12 DISTRICT, DISTRICT CHARTER SCHOOLS, SCHOOL DISTRICTS, INSTITUTE
13 CHARTER SCHOOLS, AND THE STATE CHARTER SCHOOL INSTITUTE USE TO
14 COLLECT AND REPORT DATA CONCERNING:

15 (I) INSTRUCTIONAL HOURS;

16 (II) SCHOOL CALENDARS; AND

17 (III) THE NUMBER OF HOURS STUDENTS SPEND ON INSTRUCTIONAL
18 TIME DURING THE SCHOOL YEAR.

19 (b) THE DEPARTMENT SHALL COLLECT FROM SCHOOLS OF A
20 SCHOOL DISTRICT, DISTRICT CHARTER SCHOOLS, SCHOOL DISTRICTS,
21 INSTITUTE CHARTER SCHOOLS, AND THE STATE CHARTER SCHOOL
22 INSTITUTE, AT A MINIMUM, THE FOLLOWING DATA:

23 (I) DAYS OF INSTRUCTION FOR ELEMENTARY AND SECONDARY
24 SCHOOLS;

25 (II) INSTRUCTIONAL HOURS FOR ELEMENTARY AND SECONDARY
26 SCHOOLS;

27 (III) ESTIMATED NON-INSTRUCTIONAL HOURS, SCHOOL CLOSURES,
28 SNOW DAYS, AND TIME SPENT ON LUNCH AND PASSING BETWEEN CLASSES;
29 AND

30 (IV) THE NUMBER OF DAYS AND PERCENTAGE OF THE SCHOOL
31 YEAR STUDENTS WERE PLACED ON ABBREVIATED SCHOOL DAY SCHEDULES,
32 AS DEFINED IN SECTION 22-20-122.

33 (2) THE DEPARTMENT SHALL PUBLISH THE DATA IN AN ACCESSIBLE
34 REPORT ON THE DEPARTMENT'S WEBSITE, INCLUDING ON THE
35 DEPARTMENT'S WEB PAGE FOR SCHOOL AND DISTRICT DATA."
