

## SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Hinrichsen

1 Amend reengrossed bill, page 6, line 27, after "TIME" insert "AND THE  
2 ADDRESS WHERE THE FOOD, BEVERAGES, OR OTHER GOODS MUST BE  
3 PICKED UP,".

4 Page 8, line 17, strike "TASK," and substitute "TASK FOR WHICH THE  
5 DRIVER WAS PAID ON A PER-DELIVERY-TASK OR A PER-TRANSACTION  
6 BASIS, BUT NOT FOR A DRIVER WHO IS COMPENSATED FOR A BLOCK OF TIME  
7 FOR MULTIPLE DELIVERIES,".

8 Page 8, after line 21 insert:

9           "(III) (A) FOR EACH DELIVERY TASK THAT IS COMPENSATED IN  
10 A BLOCK OF TIME FOR MULTIPLE DELIVERIES, THE DNC SHALL CALCULATE  
11 THE MILES TRAVELED TO COMPLETE A DELIVERY TASK FROM THE PICK-UP  
12 LOCATION WHERE THE DRIVER WAS DIRECTED TO BEGIN THE DELIVERY  
13 TASK TO THE LOCATION WHERE THE DRIVER DROPPED OFF THE LAST ITEM  
14 TO BE DELIVERED AS PART OF THAT DELIVERY TASK.

15           (B) FOR EACH DELIVERY TASK THAT IS COMPENSATED IN A BLOCK  
16 OF TIME FOR MULTIPLE DELIVERIES, THE DNC SHALL NOTIFY THE DRIVER  
17 THAT ANY ADDITIONAL MILES THE DRIVER INCURRED TRAVELING TO THE  
18 PICK-UP LOCATION WHERE THE DRIVER WAS DIRECTED TO BEGIN THE  
19 DELIVERY TASK AND TRAVELING FROM THE LOCATION WHERE THE DRIVER  
20 WAS DIRECTED TO MAKE THE LAST DELIVERY MAY BE ELIGIBLE FOR TAX  
21 MILEAGE DEDUCTIONS UNDER STATE AND FEDERAL LAW.

22           (C) AS PART OF THE DISCLOSURES MADE PURSUANT TO SUBSECTION  
23 (3)(e)(I) OF THIS SECTION, THE DNC SHALL DISCLOSE TO THE DRIVER THAT  
24 FOR EACH DELIVERY TASK THAT IS COMPENSATED IN A BLOCK OF TIME FOR  
25 MULTIPLE DELIVERIES, THE MILEAGE REPORT ONLY INCLUDES MILES  
26 TRAVELED FROM THE LOCATION WHERE THE DRIVER BEGAN THE DELIVERY  
27 TASK TO THE LOCATION WHERE THE DRIVER DROPPED OFF THE LAST ITEM  
28 TO BE DELIVERED AS PART OF THAT DELIVERY TASK.".

29 Renumber succeeding subparagraph accordingly.
