

1 Amend reengrossed bill, page 3, line 24, strike "(2.1)" and substitute
2 "(2.1), (2.2), and (2.3)".

3 Page 4, after line 18, insert:

4 "(2.2) (a) DURING THE 2024 LEGISLATIVE INTERIM, THE
5 COMMITTEE SHALL STUDY THE ISSUE OF CARELESS DRIVING, DESCRIBED IN
6 SECTION 42-4-1402, THAT RESULTS IN ACCIDENTAL DEATH. THE
7 COMMITTEE SHALL STUDY THE FREQUENCY OF CARELESS DRIVING
8 INCIDENTS THAT RESULT IN ACCIDENTAL DEATH AND WHETHER THE
9 CURRENT POSSIBLE CIVIL AND CRIMINAL CHARGES, INCLUDING CHARGES
10 THAT MAY BE BROUGHT IN ADDITION TO THOSE FOR CARELESS DRIVING,
11 AND ASSOCIATED PENALTIES, ARE APPROPRIATE.

12 (b) AS PART OF ITS STUDY, THE COMMITTEE SHALL REQUEST INPUT
13 FROM COUNTY COURT JUDGES, THE COLORADO STATE PATROL, AND OTHER
14 LAW ENFORCEMENT AGENCIES.

15 (c) THE COMMITTEE MAY MAKE RECOMMENDATIONS TO THE
16 GENERAL ASSEMBLY CONCERNING CARELESS DRIVING INCIDENTS THAT
17 RESULT IN ACCIDENTAL DEATH. IF THE COMMITTEE RECOMMENDS
18 LEGISLATION, THE LEGISLATION IS TREATED AS LEGISLATION
19 RECOMMENDED BY AN INTERIM LEGISLATIVE COMMITTEE FOR PURPOSES
20 OF ANY INTRODUCTION DEADLINES OR BILL LIMITATIONS IMPOSED BY THE
21 JOINT RULES OF THE GENERAL ASSEMBLY. IF THE COMMITTEE DOES NOT
22 RECOMMEND LEGISLATION, THE COMMITTEE SHALL REPORT TO THE
23 GENERAL ASSEMBLY, IN WRITING, THE FINDINGS OF ITS STUDY AND ANY
24 RECOMMENDATIONS OF THE COMMITTEE. THE WRITTEN FINDINGS AND
25 RECOMMENDATIONS MAY BE INCLUDED IN THE COMMITTEE'S FINAL
26 REPORT MADE FOLLOWING ITS WORK DURING THE 2024 LEGISLATIVE
27 INTERIM.

28 (d) THIS SUBSECTION (2.2) IS REPEALED, EFFECTIVE JULY 1, 2025.".

29 Page 4, strike lines 19 through 21.

30 Rerumber succeeding sections accordingly.

31 Page 4, line 22, strike "**definition - repeal.**".
