Committee on Finance.

HB24-1135 be amended as follows:

1 Amend printed bill, page 12, before line 15 insert:

2 **"SECTION 6.** In Colorado Revised Statutes, 43-2-145, **add** (2.3)

3 as follows:

4 **43-2-145. Transportation legislation review - committee -**
5 **definition - repeal.** (2.3) (a) DURING THE 2024 LEGISLATIVE INTERIM,
6 THE COMMITTEE SHALL STUDY THE ISSUE OF THE APPROPRIATE PENALTY
7 FOR FAILING TO MAINTAIN MOTOR VEHICLE OR LOW-POWERED SCOOTER
8 INSURANCE AND PRESENT EVIDENCE OF INSURANCE TO A REQUESTING
9 OFFICER, AS REQUIRED IN SECTION 42-4-1409. ANY REQUIREMENT TO
10 MAINTAIN INSURANCE TO OPERATE A COMMERCIAL VEHICLE, AND THE
11 PENALTY FOR NOT MAINTAINING COMMERCIAL VEHICLE INSURANCE, IS
12 NOT WITHIN THE SCOPE OF THE STUDY REQUIRED IN THIS SUBSECTION
13 (2.3).

14 (b) AS PART OF ITS STUDY, THE COMMITTEE SHALL REQUEST INPUT
15 FROM COUNTY COURT JUDGES, THE COLORADO STATE PATROL AND OTHER
16 LAW ENFORCEMENT AGENCIES, THE COLORADO DISTRICT ATTORNEYS'
17 COUNCIL, THE OFFICE OF STATE PUBLIC DEFENDER, PRIVATE ATTORNEYS
18 WHO DEFEND PERSONS IN ACTIONS RELATED TO MAINTAINING MOTOR
19 VEHICLE INSURANCE, VICTIMS OF PERSONS DRIVING WITHOUT INSURANCE,
20 PERSONS WHO WERE CONVICTED OF DRIVING WITHOUT INSURANCE, THE
21 DEPARTMENT OF REVENUE, AND CRIMINAL JUSTICE REFORM
22 ORGANIZATIONS IN COLORADO. UPON APPROVAL OF THE EXECUTIVE
23 COMMITTEE OF THE LEGISLATIVE COUNCIL, THE COMMITTEE MAY HOLD
24 HEARINGS AWAY FROM THE CAPITOL AS PART OF THE STUDY.

25 (c) THE COMMITTEE MAY MAKE RECOMMENDATIONS TO THE
26 GENERAL ASSEMBLY CONCERNING THE APPROPRIATE PENALTY FOR FAILING
27 TO MAINTAIN INSURANCE AND PRESENT EVIDENCE OF INSURANCE TO A
28 REQUESTING OFFICER. IF THE COMMITTEE RECOMMENDS LEGISLATION, THE
29 LEGISLATION IS TREATED AS LEGISLATION RECOMMENDED BY AN INTERIM
30 LEGISLATIVE COMMITTEE FOR PURPOSES OF ANY INTRODUCTION
31 DEADLINES OR BILL LIMITATIONS IMPOSED BY THE JOINT RULES OF THE
32 GENERAL ASSEMBLY. IF THE COMMITTEE DOES NOT RECOMMEND
33 LEGISLATION, THE COMMITTEE SHALL REPORT TO THE GENERAL ASSEMBLY,
34 IN WRITING, THE FINDINGS OF ITS STUDY AND ANY RECOMMENDATIONS OF
35 THE COMMITTEE. THE WRITTEN FINDINGS AND RECOMMENDATIONS MAY
36 BE INCLUDED IN THE COMMITTEE'S FINAL REPORT MADE FOLLOWING ITS
37 WORK DURING THE 2024 LEGISLATIVE INTERIM.

38 (d) THIS SUBSECTION (2.3) IS REPEALED, EFFECTIVE JULY 1, 2025.".
