Second Reading

1 Amend printed bill, page 7, strike line 14 and substitute "SAFETY AND
2 SEND THOSE WRITTEN FINDINGS TO THE APPLICANT WITHIN THREE DAYS
3 AFTER THE DATE THE COUNTY PERMITTING AGENCY DENIES THE
4 APPLICATION."

5 Page 8, line 8, strike "SHALL" and substitute "SHALL, WITHIN THREE DAYS
6 AFTER THE DATE THE COUNTY PERMITTING AGENCY DETERMINES THE
7 APPLICATION IS NOT SUFFICIENT,".

8 Page 10, after line 5 insert:

9 "(8) REGARDLESS OF THE ORDINANCE OR RESOLUTION ADOPTED BY
10 A BOARD OF COUNTY COMMISSIONERS IN ACCORDANCE WITH SUBSECTION
11 (2)(a) OF THIS SECTION, A COUNTY PERMITTING AGENCY SHALL, WITHIN
12 THREE DAYS AFTER THE DATE THE COUNTY PERMITTING AGENCY MAKES
13 THE DETERMINATION TO APPROVE, CONDITIONALLY APPROVE, OR DENY AN
14 APPLICATION, SEND NOTICE TO AN APPLICANT FOR AN EV CHARGER
15 PERMIT THAT STATES THE COUNTY PERMITTING AGENCY'S DETERMINATION
16 ON THE APPLICANT'S EV CHARGER PERMIT APPLICATION."

17 Page 13, strike line 27 and substitute "APPLICANT WITHIN THREE DAYS
18 AFTER THE DATE THE MUNICIPAL PERMITTING AGENCY DENIES THE
19 APPLICATION."

20 Page 14, line 21, strike "SHALL" and substitute "SHALL, WITHIN THREE
21 DAYS AFTER THE DATE THE MUNICIPAL PERMITTING AGENCY DETERMINES
22 THE APPLICATION IS NOT SUFFICIENT,".

23 Page 16, after line 18 insert:

24 "(8) REGARDLESS OF THE ORDINANCE OR RESOLUTION ADOPTED BY
25 THE GOVERNING BODY OF A MUNICIPALITY IN ACCORDANCE WITH
26 SUBSECTION (2)(a) OF THIS SECTION, A MUNICIPAL PERMITTING AGENCY
27 SHALL, WITHIN THREE DAYS AFTER THE DATE THE MUNICIPAL PERMITTING
28 AGENCY MAKES THE DETERMINATION TO APPROVE, CONDITIONALLY
29 APPROVE, OR DENY AN APPLICATION, SEND NOTICE TO AN APPLICANT FOR
30 AN EV CHARGER PERMIT THAT STATES THE MUNICIPAL PERMITTING
31 AGENCY'S DETERMINATION ON THE APPLICANT'S EV CHARGER PERMIT
32 APPLICATION."
