

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB24-1216 be amended as follows:

1 Amend printed bill, page 10, strike lines 13 through 27 and substitute:

2           **"22-108-105. Justice-engaged students interagency working**  
3 **group - duties - recommendations - rules.** (1) ON OR BEFORE JULY 1,  
4 2024, THE DEPARTMENT SHALL CONVENE AN INTERAGENCY WORKING  
5 GROUP COMPRISED OF MEMBERS FROM THE DEPARTMENT OF EDUCATION,  
6 AS APPOINTED BY THE COMMISSIONER; THE DEPARTMENT OF HUMAN  
7 SERVICES, AS APPOINTED BY THE EXECUTIVE DIRECTOR; THE DIVISION OF  
8 YOUTH SERVICES, AS APPOINTED BY THE EXECUTIVE DIRECTOR OF THE  
9 DEPARTMENT OF HUMAN SERVICES; AND THE JUDICIAL DEPARTMENT, AS  
10 APPOINTED BY THE CHIEF JUSTICE.

11           (2) THE INTERAGENCY WORKING GROUP SHALL, AT A MINIMUM,  
12 REVIEW AND MAKE RECOMMENDATIONS TO THE DEPARTMENT OF  
13 EDUCATION AND THE JOINT EDUCATION COMMITTEES OF THE HOUSE OF  
14 REPRESENTATIVES AND THE SENATE NO LATER THAN DECEMBER 1, 2024,  
15 REGARDING:

16           (a) CRITERIA AND A MECHANISM FOR IDENTIFYING AND  
17 QUANTIFYING THE NUMBER OF JUSTICE-ENGAGED STUDENTS;

18           (b) INDICATORS OF AND CONTRIBUTING FACTORS TO ACADEMIC  
19 ATTAINMENT;

20           (c) DATA-SHARING AGREEMENTS AND REGULATORY AND  
21 STATUTORY CHANGES REQUIRED TO IMPLEMENT THE RECOMMENDATIONS;

22           (d) ADDITIONAL FUNDING OR SYSTEM ENHANCEMENTS REQUIRED  
23 TO IMPLEMENT THE RECOMMENDATIONS MADE PURSUANT TO THIS  
24 SUBSECTION (2); AND

25           (e) ANY OTHER RECOMMENDATIONS THAT THE INTERAGENCY  
26 WORKING GROUP FINDS RELEVANT TO BETTER UNDERSTAND OUTCOMES  
27 FOR JUSTICE-ENGAGED STUDENTS AND WAYS THE STATE CAN SUPPORT  
28 THIS POPULATION.

29           (3) THE INTERAGENCY WORKING GROUP SHALL CONSULT WITH  
30 LOCAL EDUCATION PROVIDERS TO DETERMINE WHAT DATA IS NEEDED BY  
31 DECEMBER 31, 2024.

32           (4) ON OR AFTER JULY 1, 2025, THE STATE BOARD OF EDUCATION  
33 SHALL PROMULGATE ANY NECESSARY RULES OR REQUEST STATUTORY  
34 CHANGES TO IMPLEMENT THE RECOMMENDATIONS MADE BY THE  
35 INTERAGENCY WORKING GROUP."
