22 THAT THE STUDENTS TESTED ARE REPRESENTATIVE OF THE DISTRICT'S  
23 OVERALL STUDENT POPULATION. A SMALL RURAL DISTRICT, AS DEFINED  
24 IN SECTION 22-54-103, THAT MEETS THE CRITERIA DESCRIBED IN  
25 SUBSECTIONS (2)(a)(I), (2)(a)(III), (2)(a)(IV), AND (2)(a)(V) OF THIS  
26 SECTION BUT DOES NOT MEET THE CRITERIA DESCRIBED IN SUBSECTION  
27 (2)(a)(II) OF THIS SECTION MAY USE THE CRITERIA OUTLINED IN STATE  
28 BOARD RULE FOR THE RECONSIDERATION OF ITS INITIAL ACCREDITATION  
29 ASSIGNMENT."".

5 CONTRACT FUNDS.".

15 INCLUDE, BUT ARE NOT LIMITED TO, THE EXTERNAL PARTNER'S USE OF  
16 CONTRACT FUNDS.".
