

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

HB24-1354 be amended as follows:

1 Amend reengrossed bill, strike everything below the enacting clause and
2 substitute:

3 **"SECTION 1.** In Colorado Revised Statutes, 35-80-108, **amend**
4 (2) introductory portion, (2)(f), and (2)(g); and **add** (2)(h) as follows:

5 **35-80-108. Unlawful acts - short title - disclosure requirement**

6 **- definition.** (2) It is unlawful and a violation of this ~~article~~ ARTICLE 80
7 for any person operating a pet animal facility:

8 (f) To make any misrepresentation or false promise through
9 advertisements, employees, agents, or otherwise in connection with the
10 business operations licensed pursuant to this ~~article~~ ARTICLE 80 or for
11 which an application for a license is pending; **and**

12 (g) To fail to take reasonable care to release for sale, trade, or
13 adoption only those pet animals that are free of undisclosed disease,
14 injury, or abnormality; **AND**

15 (h) (I) **WITHIN TWENTY-FOUR HOURS AFTER RECEIVING**
16 **NOTIFICATION FROM A LICENSED VETERINARIAN OR A PET ANIMAL OWNER**
17 **OF AN OUTBREAK OF AN INFECTIOUS DISEASE AT THE PET ANIMAL**
18 **FACILITY, TO FAIL TO MAKE EVERY REASONABLE ATTEMPT TO NOTIFY ALL**
19 **INDIVIDUALS WHO OWN A PET ANIMAL THAT IS IN THE POSSESSION OF THE**
20 **PET ANIMAL FACILITY OR WHO USED THE PET ANIMAL FACILITY DURING**
21 **THE REPORTED OUTBREAK AND INCUBATION PERIOD. THE PET ANIMAL**
22 **FACILITY SHALL PROVIDE NOTIFICATION OF THE OUTBREAK BY:**

23 (A) **POSTING NOTICE IN A CONSPICUOUS LOCATION ON THE PET**
24 **ANIMAL FACILITY PREMISES; OR**

25 (B) **POSTING NOTICE ON THE PET ANIMAL FACILITY'S WEBSITE, IF**
26 **ONE EXISTS; OR**

27 (C) **DIRECTLY CONTACTING A PET ANIMAL OWNER THROUGH ANY**
28 **MEANS AVAILABLE.**

29 (II) **A PET ANIMAL FACILITY SHALL DISCLOSE INFORMATION**
30 **REGARDING ANY OUTBREAK OF AN INFECTIOUS DISEASE THAT OCCURRED**
31 **AT THE PET ANIMAL FACILITY WITHIN THE PAST YEAR TO ANY PET ANIMAL**
32 **OWNER WHO REQUESTS SUCH INFORMATION.**

33 (III) **THE SHORT TITLE OF THIS SUBSECTION (2)(h) IS THE "CLINTON**
34 **PET ANIMAL NOTIFICATION ACT".**

35 (IV) **AS USED IN THIS SUBSECTION (2)(h), "PET ANIMAL FACILITY"**
36 **MEANS A PET CARE FACILITY LICENSED PURSUANT TO THIS ARTICLE 80**
37 **THAT IS USED IN WHOLE OR IN PART FOR THE PURPOSE OF PET ANIMAL DAY**
38 **CARE OR BOARDING, GROOMING, OR TRAINING PET ANIMALS.**

39 **SECTION 2. Safety clause.** The general assembly finds,

1 determines, and declares that this act is necessary for the immediate
2 preservation of the public peace, health, or safety or for appropriations for
3 the support and maintenance of the departments of the state and state
4 institutions.".
