Second Reading

1 Amend the Judiciary Committee Report, dated April 29, 2024, page 1,
2 strike lines 10 and 11 and substitute:

3 ""(VI) THREATENING TO COMMIT SUICIDE OR OTHERWISE HARM
4 ONE'S OWN PERSON, WHEN USED AS A METHOD OF COERCION,
5 CONTROL, PUNISHMENT, INTIMIDATION, OR RETALIATION AGAINST THE
6 PERSON;".

7 Amend the reengrossed bill, page 8, strike lines 17 through 19 and
8 substitute:

9 "(5) AS USED IN THIS SECTION, UNLESS THE CONTEXT
10 OTHERWISE REQUIRES, "COERCIVE CONTROL" MEANS A PATTERN OF
11 THREATENING, HUMILIATING, OR INTIMIDATING ACTIONS, INCLUDING
12 ASSAULTS OR OTHER ABUSE, THAT IS USED TO HARM, PUNISH, OR
13 FRIGHTEN AN INDIVIDUAL. "COERCIVE CONTROL" INCLUDES A PATTERN
14 OF BEHAVIOR THAT TAKES AWAY THE INDIVIDUAL'S LIBERTY OR
15 FREEDOM AND STRIPS AWAY THE INDIVIDUAL'S SENSE OF SELF,
16 INCLUDING THE INDIVIDUAL'S BODILY INTEGRITY AND HUMAN RIGHTS.
17 "COERCIVE CONTROL" INCLUDES ISOLATING THE INDIVIDUAL FROM
18 SUPPORT, EXPLOITING THE INDIVIDUAL, DEPRIVING THE INDIVIDUAL OF
19 INDEPENDENCE, AND REGULATING THE INDIVIDUAL'S EVERYDAY
