Second Reading

1 Amend printed bill, page 3, line 9, after "(7)(g)," insert "(7.5),".

2 Page 36, after line 13 insert:

3 **"(7.5) Enterprise transparency and reporting. (a)** TO ENSURE
4 TRANSPARENCY AND ACCOUNTABILITY, AND IN ADDITION TO THE REPORT
5 REQUIRED BY SUBSECTION (7)(e) OF THIS SECTION, THE ENTERPRISE
6 SHALL:

7 **(I)** PREPARE AN ANNUAL BUDGET IN ACCORDANCE WITH THE
8 REQUIREMENTS OF PART 1 OF ARTICLE 1 OF TITLE 29 AS IF THE ENTERPRISE
9 WERE A LOCAL GOVERNMENT, TO THE EXTENT POSSIBLE. EVERY FISCAL
10 YEAR, THE ENTERPRISE SHALL PROVIDE A COPY OF THE BUDGET TO
11 LEGISLATIVE COUNCIL STAFF AND THE JOINT BUDGET COMMITTEE OF THE
12 GENERAL ASSEMBLY.

13 **(II)** NO LATER THAN JULY 1, 2025, PUBLISH AND POST ON ITS
14 WEBSITE A TEN-YEAR PLAN THAT DETAILS HOW THE ENTERPRISE WILL
15 EXECUTE ITS BUSINESS PURPOSES DURING STATE FISCAL YEARS 2025-26
16 THROUGH 2034-35 AND ESTIMATES THE AMOUNT OF FUNDING NEEDED TO
17 IMPLEMENT THE PLAN. NO LATER THAN JANUARY 1, 2035, THE ENTERPRISE
18 SHALL PUBLISH AND POST ON ITS WEBSITE A TEN-YEAR PLAN FOR STATE
19 FISCAL YEARS 2035-36 THROUGH 2044-45.

20 **(III)** CREATE, MAINTAIN, AND REGULARLY UPDATE ON ITS WEBSITE
21 A PUBLIC ACCOUNTABILITY DASHBOARD THAT PROVIDES, AT A MINIMUM,
22 ACCESSIBLE AND TRANSPARENT SUMMARY INFORMATION REGARDING THE
23 IMPLEMENTATION OF ITS TEN-YEAR PLAN, THE FUNDING STATUS AND
24 PROGRESS TOWARD COMPLETION OF EACH PROJECT THAT IT WHOLLY OR
25 PARTLY FUNDS, AND ITS PER-PROJECT AND TOTAL FUNDING AND
26 EXPENDITURES;

27 **(IV)** ENGAGE REGULARLY REGARDING ITS PROJECTS AND
28 ACTIVITIES WITH THE PUBLIC, INCLUDING BUT NOT LIMITED TO SEEKING
29 INPUT FROM DISPROPORTIONATELY IMPACTED COMMUNITIES AND
30 INTEREST GROUPS THAT ARE LIKELY TO BE INTERESTED IN THE PROJECTS
31 AND ACTIVITIES; AND

32 **(V)** POST ON ITS WEBSITE THE ANNUAL REPORT REQUIRED BY
33 SUBSECTION (7)(e) OF THIS SECTION. NOTWITHSTANDING THE
34 REQUIREMENT IN SECTION 24-1-136 (11)(a)(I), THE REQUIREMENT TO
35 SUBMIT THE ANNUAL REPORT REQUIRED BY SUBSECTION (7)(e) TO THE
36 SPECIFIED LEGISLATIVE COMMITTEES CONTINUES INDEFINITELY.".
