

HOUSE COMMITTEE OF REFERENCE AMENDMENT
Committee on Education.

HB25-1278 be amended as follows:

- 1 Amend printed bill, page 8, strike line 3 and substitute "(1)(b), (4), and
2 (5); and **add** (1)(e), (1)(f), and".
- 3 Page 8, strike lines 6 through 23.
- 4 Page 8, line 24, before "(b)(I)(A)" insert "(1)".
- 5 Page 9, strike lines 13 and 14 and substitute "PERFORMANCE INDICATORS,
6 THE STATE BOARD SHALL ENSURE THAT THE CALCULATION".
- 7 Page 9, strike lines 16 through 27 and substitute "WITH DISABILITIES,
8 INCLUDING STUDENTS WHO HAVE A DISABILITY PURSUANT TO THE
9 FEDERAL "INDIVIDUALS WITH DISABILITIES EDUCATION ACT", 20 U.S.C.
10 1400 ET SEQ., BUT WHO NO LONGER MEET THE ELIGIBILITY CRITERIA FOR
11 AN INDIVIDUALIZED EDUCATION PROGRAM, AS DEFINED IN SECTION
12 22-20-103 (2)(c)".
- 13 Page 10, line 2, strike "(1)(e)(I)(B)" and substitute "(1)(e)(I)".
- 14 Page 10, lines 5 and 6, strike "A SECTION 504 PLAN, AS DEFINED IN
15 SECTION 22-20-123 (2)(c), OR".
- 16 Page 10, line 11, strike "(1)(e)(I)(B)" and substitute "(1)(e)(I)".
- 17 Page 10, after line 13 insert:

18 "(f) FOR PURPOSES OF CALCULATING PERFORMANCE FOR THE
19 PERFORMANCE INDICATOR CONCERNING STUDENT ACADEMIC
20 ACHIEVEMENT, THE STATE BOARD SHALL ENSURE THAT THE CALCULATION
21 INCLUDES CONSIDERATION OF THE PERCENTAGES OF STUDENTS ENROLLED
22 IN THE ELEVENTH GRADE IN PUBLIC HIGH SCHOOLS WHO SCORE AT EACH
23 ACHIEVEMENT LEVEL ON THE STANDARDIZED CURRICULUM-BASED
24 ACHIEVEMENT COLLEGE ENTRANCE EXAMINATION ADMINISTERED AS A
25 STATEWIDE ASSESSMENT OR THE PERCENTAGES OF STUDENTS ENROLLED
26 IN EACH OF THE GRADE LEVELS INCLUDED IN THE PUBLIC HIGH SCHOOL
27 WHO SCORE AT EACH ACHIEVEMENT LEVEL ON THE ASSESSMENTS
28 ADMINISTERED BY THE PUBLIC HIGH SCHOOL PURSUANT TO SECTION
29 22-7-1006.3.".
