

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB25-1241 be amended as follows:

1 Amend printed bill, page 3, strike lines 15 through 27.

2 Page 4, strike line 1 and substitute:

3 **"25-7-109.7. Emissions records - public accessibility - civil
4 penalties. (1) Public accessibility of emissions records. (a) BEGINNING
5 JANUARY 1, 2027, AN OWNER OR OPERATOR SHALL MAKE ALL EMISSIONS
6 RECORDS THAT THE OWNER OR OPERATOR IS REQUIRED BY STATE OR
7 FEDERAL LAW TO MAINTAIN".**

8 Page 4, strike line 7 and substitute "TO SUBSECTION (1)(a) OF THIS
9 SECTION FOLLOWING THE SAME SCHEDULE AS THE RECORDS ARE MADE
10 AVAILABLE TO THE STATE; EXCEPT THAT, ANY RECORDS PROVIDED TO THE
11 STATE MORE OFTEN THAN ONCE MONTHLY MAY BE UPLOADED TO THE
12 OWNER OR OPERATOR'S PUBLIC WEBSITE ON A MONTHLY BASIS. FOR
13 RECORDS THAT ARE PROVIDED TO THE STATE ON A QUARTERLY BASIS OR
14 LESS OFTEN, THE OWNER OR OPERATOR SHALL UPDATE SUCH RECORDS ON
15 THE OWNER OR OPERATOR'S PUBLIC WEBSITE ON OR BEFORE THE FIRST DAY
16 OF THE MONTH FOLLOWING WHEN THE RECORDS ARE MADE AVAILABLE TO
17 THE STATE.".

18 Page 4, strike lines 10 through 13 and substitute:

19 **"(d) (I) THIS SECTION APPLIES TO RECORDS THAT ARE GENERATED
20 ON OR AFTER DECEMBER 1, 2026.**

21 **(II) NOTHING IN THIS SECTION REQUIRES AN OWNER OR OPERATOR
22 TO INCLUDE RECORDS THAT WERE GENERATED BEFORE DECEMBER 1,
23 2026, ON THE OWNER OR OPERATOR'S PUBLIC WEBSITE."**

24 Page 4, after line 13 insert:

25 **"(2) Civil penalties. CIVIL PENALTIES ASSESSED AND COLLECTED
26 FOR VIOLATIONS OF THIS SECTION PURSUANT TO SECTION 25-7-122 MUST
27 BE CREDITED TO THE AIR QUALITY ENTERPRISE CASH FUND CREATED IN
28 SECTION 25-7-103.5 (4)."**
