1 Strike the Judiciary Committee Report, dated April 30, 2025, and
2 substitute:

3 "Amend engrossed bill, page 2, after line 11 insert:

4 "(a.5) IN CONSIDERATION OF A REVOCATION OR DENIAL OF A
5 LICENSE PURSUANT TO SUBSECTION (8)(a) OF THIS SECTION, A CRIMINAL
6 CONVICTION MAY ONLY BE CONSIDERED FOR A THREE-YEAR PERIOD
7 BEGINNING ON THE DATE OF CONVICTION OR THE END OF INCARCERATION,
8 WHICHEVER DATE IS LATER, IF THE APPLICANT OR LICENSEE HAS NOT BEEN
9 CONVICTED OF ANY OTHER CRIMINAL OFFENSE DURING THE THREE-YEAR
10 PERIOD. AFTER THE THREE-YEAR PERIOD, ONLY THE INDIVIDUAL'S
11 APPLICATION OR LICENSE MAY BE CONSIDERED AND ONLY IN THE SAME
12 MANNER AS THAT OF AN INDIVIDUAL WHO DOES NOT POSSESS A PRIOR
13 CRIMINAL RECORD; EXCEPT THAT A CONVICTION FOR A CRIME THAT IS
14 DIRECTLY RELATED TO THE AUTO INDUSTRY MAY BE CONSIDERED AT ANY
15 TIME.".

16 Page 2 of the bill, after line 18 insert:

17 "(a.5) IN CONSIDERATION OF A REVOCATION OR DENIAL OF A
18 LICENSE PURSUANT TO SUBSECTION (8)(a) OF THIS SECTION, A CRIMINAL
19 CONVICTION MAY ONLY BE CONSIDERED FOR A THREE-YEAR PERIOD
20 BEGINNING ON THE DATE OF CONVICTION OR THE END OF INCARCERATION,
21 WHICHEVER DATE IS LATER, IF THE APPLICANT OR LICENSEE HAS NOT BEEN
22 CONVICTED OF ANY OTHER CRIMINAL OFFENSE DURING THE THREE-YEAR
23 PERIOD. AFTER THE THREE-YEAR PERIOD, ONLY THE INDIVIDUAL'S
24 APPLICATION OR LICENSE SHALL BE CONSIDERED AND ONLY IN THE SAME
25 MANNER AS THAT OF AN INDIVIDUAL WHO DOES NOT POSSESS A PRIOR
26 CRIMINAL RECORD; EXCEPT THAT A CONVICTION FOR A CRIME THAT IS
27 DIRECTLY RELATED TO THE AUTO INDUSTRY MAY BE CONSIDERED AT ANY
28 TIME.".

29 Strike "portion" and substitute "portion; and **add** (8)(a.5)" on: **Page 2**,
30 lines 3 and 13.".
