1 Amend the Health and Human Services Committee Report, dated May 3,  
2 2025, page 3 of the report, before line 15, insert:

3       "(2) NOTWITHSTANDING ANY PROVISION OF LAW TO THE  
4 CONTRARY, A MANUFACTURER MAY DIRECTLY OR INDIRECTLY REQUIRE,  
5 INCLUDING AS A CONDITION, A 340B COVERED ENTITY, AS DEFINED IN  
6 340B (a)(4) OF THE FEDERAL "PUBLIC HEALTH SERVICE ACT", 42 U.S.C.  
7 SEC. 256b (a)(4), A PHARMACY CONTRACTED WITH A 340B COVERED  
8 ENTITY, OR ANY OTHER LOCATION AUTHORIZED TO RECEIVED 340B DRUGS  
9 BY A 340B COVERED ENTITY TO SUBMIT ANY HEALTH INFORMATION,  
10 CLAIMS OR UTILIZATION DATA, PURCHASING DATA, PAYMENTS DATA, OR  
11 OTHER DATA THAT DOES NOT RELATE TO A CLAIM SUBMITTED TO A  
12 FEDERAL HEALTH CARE PROGRAM UNLESS THAT DATA IS VOLUNTARILY  
13 FURNISHED BY THE COVERED ENTITY OR OTHERWISE REQUIRED TO BE  
14 FURNISHED UNDER APPLICABLE FEDERAL LAW."
