Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB25-1278 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Education Committee Report, dated March 26, 2025, page 1,
2 line 1, strike "(1)(d)," and substitute "(1)(d), (2)(b),".

3 Page 1, line 6, strike "at the request of a local education provider," and
4 substitute "~~at the request of a local education provider,~~".

5 Page 1, after line 14 insert:

6 "(2) (b) The department of education shall select and the state
7 shall pay the costs of administering an assessment that is administered
8 throughout the United States and relied upon by institutions of higher
9 education, referred to in this section as the "curriculum-based,
10 achievement college entrance exam". Every five years, the department OF
11 EDUCATION shall request competitive bids and contract for the
12 curriculum-based, achievement college entrance exam. At a minimum,
13 the curriculum-based, achievement college entrance exam must test in the
14 areas of reading, writing, mathematics, and science. Each local education
15 provider shall administer the curriculum-based achievement college
16 entrance exam for students enrolled in eleventh grade. ~~The local~~
17 ~~education provider shall administer the writing portion of the~~
18 ~~curriculum-based, achievement college entrance exam to each student~~
19 ~~who requests the opportunity to take the writing portion. The department~~
20 ~~shall pay the costs of administering the writing portion of the exam."~~

5 22-20-123. THE STATE BOARD MAY ADOPT RULES TO IMPLEMENT THIS
6 SUBSECTION (3)(e).".

9 PRACTICABLE BUT NO LATER THAN JUNE 1 OF EACH YEAR," and substitute
10 "NO LATER THAN JUNE 1 OF EACH YEAR OR AS SOON AS PRACTICABLE,"."

11 Page 9 of the report, line 30, before "(4)," insert "(2.7),".

12 Page 10 of the report, after line 27 insert:

13 "(2.7) FOR THE 2024-25 AND 2025-26 BUDGET YEARS, THE
14 DEPARTMENT SHALL, WITHIN EXISTING RESOURCES, COMPLY WITH
15 SUBSECTIONS (2) AND (4) OF THIS SECTION. FOR THE 2026-27 BUDGET
16 YEAR, AND FOR BUDGET YEARS THEREAFTER, THE DEPARTMENT MAY
17 SUBMIT A REQUEST TO THE GENERAL ASSEMBLY FOR ADDITIONAL
18 RESOURCES THROUGH THE ANNUAL BUDGET PROCESS."

19 Page 16 of the report, strike lines 27 through 34 and substitute:

20 "Page 38 of the printed bill, line 3, strike "NOVEMBER 1, 2026," and

5 **SECTION 21. Appropriation - adjustments to 2025 long bill.**

6 (1) To implement this act, the cash funds appropriation from the state

7 education fund created in section 17 (4)(a) of article IX of the state

8 constitution made in the annual general appropriation act for the 2025-26

9 state fiscal year to the department of education for the statewide

10 assessment program is reduced by \$456,000.

11 (2) To implement this act, the general fund appropriation made in

12 the annual general appropriation act for the 2025-26 state fiscal year to

13 the department of education for use by school quality and support for the

14 local accountability system grant program is reduced by \$81,000.

15 (3) For the 2025-26 state fiscal year, \$559,187 is appropriated to

16 the department of education for use by school quality and support. This

17 appropriation is from the general fund and is based on an assumption that

18 the division will require an additional 3.4 FTE. To implement this act, the

19 division may use this appropriation for accountability and improvement

20 planning.
